Evolutionary Tightrope John J. Coleman, III, M.D., Chair



ow much should an organization change in response to the pressures of society; both specialty society and society at large? Should an entity entrusted with the important function of certification of surgery specialty expertise have principles and practices that are eternal, immutable and fundamental or should these characteristics be resonant to the changing world? Will such change vitiate its purpose and function? Certainly my perspective of the Board prior to being elected a director was that of an organization founded in 1937 by the wisdom and foresight of the leaders of a developing specialty given impetus by the recent World War who established principles and methods that changed little up to the present. My perspective now is quite different and I will report on this, emphasizing changes that have occurred during the seven years that I have served.

Knowledge of the mission of the Board is critical to the understanding of these changes with respect to the specialty of Plastic Surgery and the public.

"The mission of the American Board of Plastic Surgery is to promote safe, ethical, efficacious plastic surgery to the public by maintaining high standards for the education, examination, certification and recertification of plastic surgeons as specialists and sub-specialists."

To effect this mission, the Board has four essential purposes:

- 1. To establish requirements for the qualifications of applicants who request a certificate of their ability in the field of plastic surgery in its broadest sense.
- 2. To conduct examinations of approved candidates who seek certification by the Board.
- 3. To issue certificates to those who meet the Board's requirements and pass the respective examinations.
- 4. To do and engage in any and all lawful activities that may be indicated or reasonably related to any of the foregoing purposes.

Clearly, purposes one to three are intimately linked to the examination process and purpose four is a catchall that facilitates action. I will thus report to you on these two categories.

EXAMINATIONS

The written examination has changed significantly in the last several years. The written examination committee under the leadership of Dr. Bruce L. Cunningham and subsequently Dr. John A. Persing has refined the process greatly. The previous examination question pool has been reviewed entirely and each question validated by the National Board of Medical Examiners (NBME), a meticulous and time consuming process. New questions from the pool now come from question writing sessions prior to each Board meeting and oral examination in which members of the four advisory councils and others create questions that are again subjected to NBME scrutiny. This laborious process has resulted in marked decrease in the number of questions necessary to create the examination from 900 in the past to 400 presently, while improving the overall accuracy of the questions when validated after the examination by the NBME (this year's examination demonstrating an industry-standard .90 reliability for the total exam score).

Another enormous step forward in the qualifying examination has been the development of a computerized test. The first such examination was administered this year on October 18th at Prometric testing sites throughout the country and was an unqualified success, saving candidates considerable expense and time away from practice while providing a secure and accurate examination. The ease with which it transpired belies the efforts of the written examination committee.

The Oral Examination of the Board is looked upon by the American Board of Medical Specialties as one of the finest examples of its genre. Since the inception of the Board, the scrutiny of the candidates' own cases has been an integral part of the examination. With the increasing recognition of the broad scope of plastic surgery practice, the past method of candidate selection of cases to fit into predetermined categories has given way to the concept of "the practice biopsy" or board selection of cases that represent best the daily behavior of the candidate. This session of the Oral Examination allows the Board not only to assess judgment in patient care and execution of surgical technique, but also application of ethical principles to practice. In response to concern by candidates that they were being prevented from joining managed care panels because of lack of certification,

the ABPS shortened the case collection period from one year to seven months which, with the move of the written examination to the September after residency graduation, has allowed certification at fourteen months after residency rather than the previous twenty-eight months.

A number of mechanistic changes in the oral examination have improved its quality as well. The case collection method has changed to an Internet based process that greatly facilitates collection by the candidates and review by the Board's oral examination committee. Prior to the two Theory and Practice sessions during the exam, the candidates are given five minutes to review the cases before entering the examination room. According to both candidates and examiners this has decreased the ambient anxiety level and has improved the process of information exchange. In recent oral examinations. candidates have been required to submit critiques of the examination with specific and open-ended questions posed. This feedback has allowed appropriate modification of the process and improvement of the examination.

Although the ABPS was the next to last Board to engage the recertification process, it has rapidly become a leader in the movement toward meaningful recertification and maintenance of certification. The efforts of Dr. Carolyn L. Kerrigan and more recently Dr. Ronald E. Iverson and their committee have created an excellent model that will be used in the first ABPS recertification examination in April of 2003. The modular aspect of the knowledge portion of the examination will recognize subspecialization with each module (comprehensive, hand, cosmetic, craniomaxillofacial) consisting of 150 specialty questions and 50 general questions. The case collection process is similar to that of the oral examination.

At the September 2002 ABMS meeting, the ABPS presented its initial plan for maintenance of certification. This was highly acclaimed by the assembly. There are three basic components to the process. The knowledge assessment component, on a seven to ten year interval, will be similar to the present recertification examination. It will be administered by computer in a secure setting but utilizing questions taken totally from the public domain, including previous In-service examination questions provided by the PSEF and reviewed by the Board. Commitment to lifelong learning will be comparable to present ASPS CME requirements for maintenance of active membership and will probably be assessed at three-year intervals. Professionalism will be measured in a number of ways not yet completely determined but will review current licensure, practice profile and performance and peer and/or patient evaluation. Recognition of subspecialization after successful recertification or maintenance of certification will be provided by the appropriate specialty society.

... REASONABLY RELATED TO ANY OF THE FOREGOING

Many of the changes in the examinations were directly related to perceived changes in our smaller and larger society, but there have been important other changes in the Board profile as well.

In January 1997, Chair Dr. Martin C. Robson called a special meeting of the Board in Philadelphia which had some farreaching effects on the Board. This was a particularly divisive time in the specialty with troublesome relationships with other ABMS boards and considerable divisiveness within Plastic Surgery itself. As a result of this meeting, the Board Office was completely reorganized and a new administrator, Mrs. Terry Cullison, RN, MSN hired. The decision was made to create an Executive Director position which led to the subsequent hiring of R. Barrett Noone, MD. This was an enormous step in streamlining the functions and daily activities of the Board office. Also during this meeting, the By-Laws were amended and subsequently approved creating a progression to leadership of three years instead of two and making the Chair year an extra year added to the six-year term. These changes have lengthened the corporate memory of the Board greatly, making it more effective in its dealings with organized medicine and improving its responsiveness to candidates and diplomates.

In July 1998, in response to concerns that the Board was perceived by its diplomates as exclusive, isolated and unrealistic, Chair Dr. Kenna S. Given appointed an Ad Hoc Committee on governance and professional relations, the recommendations of which were debated at a subsequent extra summer meeting in Philadelphia on July 30, 1999. An important result of this meeting was the permanent formation of Advisory Councils to the Board in Hand, Cosmetic, Craniomaxillofacial and Comprehensive Plastic Surgery in May 2000. These Councils, which convene with the Board prior to each meeting, have been invaluable in providing questions for the written and recertification examinations, in improving relationships with the specialty societies and in identifying candidates for subsequent directorship. The Ad Hoc Committee's recommendations and subsequent implementation by ABPS reaffirmed the Board's commitment to the public good while engaging the full spectrum of subspecialization of Plastic Surgery. At the present, through the directors and Advisory Council Members, every practitioner of the specialty of Plastic Surgery has a voice on the Board.

Other important changes were initiated by Chair Dr. William B. Riley, Jr.'s Ad Hoc Committee on technology, which outlined a case collection process that works in a linear fashion and has served as the template for the current procedural statistics collection by the ASPS, Tracking Outcomes in Plastic Surgery (TOPS).

Responding to the desires of the public and the ASPS program to brand quality in Plastic Surgery with society membership and thus Board certification, the ABPS under the leadership of Chairs Dr. David J. Smith, Jr. and Dr. Bruce M. Achauer has recently taken a much more active role in assessing the ethical behavior of its diplomates and candidates. Prior to 1999, only one ABPS certificate had been revoked. Since then, 22 certificates have been revoked and the Ethics Committee takes an aggressive stance toward deviation from ethical behavior in the practice of Plastic Surgery. Revocation of state licensure is now reinforced by revocation of ABPS certification. Board Office staff and legal counsel pursue false representation of ABPS certification by other specialists. Concerns over false advertising by candidates for the ABPS have resulted in a screening process of all marketing material for each candidate for the oral examination. This representation is dealt with by postponement of eligibility or more severely, again as determined appropriate by the Ethics Committee and the Board. After the successful completion of the written examination, a list of all candidates for the oral examination is published in the Board's annual newsletter requesting notification from diplomates of any concerns over ethical practice by these individuals. Such scrutiny and action will protect the value of the certificate to the individual diplomate and to the public at large.

I have highlighted the major changes that I have seen in the ABPS during my period as Director. To me, they appear many and meaningful. Although seven years within the framework of Darwinian theory applies more relevantly to protozoans than to complex human organizations, I strongly feel that the ABPS has evolved in this period into an organization that will be fit in the future to survive and to continue to serve.

he Annual Newsletter of the Board provides an excellent opportunity for the officers, directors and staff to update the diplomates and our other constituents about the events and activities of the Board over the past year. We are always open to suggestions and comments from readers as we strive to improve our lines of communication.

Bruce M. Achauer, M.D. (1942-2002)

The Board, and the entire specialty of plastic surgery, mourn the loss of Dr. Bruce M. Achauer, immediate past Chair of the Board, who died while attending the annual meeting of the American Society of Plastic Surgeons in San Antonio, TX on November 4, 2002. Dr. Achauer served the Board as director and as Chair of the By-Laws and Publications Committee, assuming the responsibility of Chair of the Board in his seventh year, 2001-2002.

A well-known pioneer in plastic surgery, Dr. Achauer served as Professor of Plastic Surgery at the University of California, Irvine, and as director of its burn unit. He completed the editorship of a five-volume textbook of plastic surgery entitled *Plastic Surgery Indications, Operations and Outcomes*, and he was the author of over 125 scientific articles.

Dr. Achauer was very active in plastic surgery education and in international service, leading to his presidency of the Plastic Surgery Educational Foundation (PSEF) in 1999-2000.

A memorial service was held on November 17, 2002, in Long Beach, CA. Dr. Achauer is survived by his wife Tamara and two daughters, Allison and Hillary. Contributions in his memory can be made to Orange County Burn Association (714) 456-6011 or the PSEF (847) 228-3358.

Ethics

The Board has been placing increasing emphasis on assuring the public that candidates for examination and certified diplomates are practicing plastic surgery in an ethical manner. Because of this commitment, the work of the Ethics Committee has increased over the past few years, with particular attention to false and deceptive advertising and restrictions on licensure. As the Recertification Program continues, the Board will have a mechanism in place to continue to review ethical concerns.

The Board has always required candidates and diplomates to adhere to the Code of Ethics of the American Society of Plastic Surgeons (ASPS). Although the principles of ethical practice are well established, the Board decided to establish a separate Code of Ethics from the ASPS. This decision was based on the different structure and missions of the Board and ASPS. The Board approved the Code of Ethics at the Semi-Annual Meeting in November, 2002. The new Code of Ethics is produced in detail in this Newsletter.

Computer-Based Tests

The Board's venture into the realm of computer based testing was very successful in 2002. The examination for certification and recertification in the Subspecialty of Surgery of the Hand in August/September was offered as both a paper and pencil examination in Chicago or a computer-based test at a Prometric Testing Center ® near the diplomate's home. The Board received a vote of confidence in its decision to move to computer tests when 77% of the plastic surgeons taking the hand examination selected the computer format. All of the 242 candidates for initial certification who registered for the Written Examination, given on October 18, 2002, were examined by computer at a Prometric Center of their choice. This program proved to be very successful, and the Written Examination continues to increase in quality when compared to previous years. The psychometric evaluation of the 2002 Examination even exceeded the high standards produced in 2001. The candidates appreciated the convenience and other advantages of taking the examination by computer, mainly the cost savings by eliminating travel and hotel expenses and the decreased time required away from practice.

Oral Examination: Change in time and place

In an effort to give candidates for the Oral Examination the opportunity to present more mature case lists for review by the examination committee. the start of the case list collection period has been moved from July 1 to September 1, 2002 for the 2003 Oral Examination. The seven-month period will end on March 31, 2003. This change will allow the recent residency graduate an additional two months to get a practice "up and running" before collecting cases for the examination. Because seven months will still be required for collection, the date of the examination has been moved back from September to November, 2003. There has also been a change in the location for the 2003 Oral Examination, which will be administered in Phoenix, AZ on November 13-15, 2003. Candidates are reminded that they must be in the active practice of plastic surgery throughout the entire sevenmonth case collection.

Recertification

The first Recertification Examination will be offered as a computer-based test on April 25, 2003 at Prometric Testing Centers located throughout the United States and Canada. This will be the first opportunity for the 200 diplomates who received ten-year timed-limited certificates in 1995 to sit for the examination. Applications were received by the August 30, 2002 deadline from 109 candidates for Recertification, 25 of whom were those with undated certificates. The Board congratulates those "grandfathers" who will be taking the Recertification Examination on a voluntary basis, and has the desire that more diplomates with undated certificates will register for subsequent years.

Assignments to one of the four recertification modules, including comprehensive plastic surgery, cosmetic surgery, craniomaxillofacial surgery and hand surgery, have been based on the six-month case list submitted by the candidates by an internet-based program. Those certified in 1995 who did not elect to register for the 2003 examination will have two more opportunities, in 2004 and 2005, to complete the Recertification Program.

Most of the questions of the 2003 examination will have been produced

in the public domain as questions in the Plastic Surgery Educational Foundation (PSEF) In-Service Examinations over the past five years. In an effort to make preparation for the examination an educational experience, the PSEF will offer a CD-ROM study guide containing appropriate questions from the previous five years of In-Service Examinations, including explanation of the correct answers in syllabus form.

Advisory Councils

The past two years have witnessed the ever-increasing importance of the Board's four Advisory Councils. The Councils were established in May 2000 to assist the Board's efforts in recognition of subspecialization, preparation for Recertification and Maintenance of Certification®, development of criteria for examination module eligibility, and examination question writing and editing. Members of the Advisory Councils, nominated by plastic surgery organizations and patterned after the four modules of recertification, are listed later in this Newsletter. The Councils meet at the same time as the Semi-Annual and Annual Meetings of the Board. Their work is coordinated through the Chair of each Council, who is a current director of the Board. The Board recognizes and appreciates the assistance and dedication of its Advisory Councils.

The American Board of Medical **Specialties (ABMS)**

In March 2000, the 24 member boards voted unanimously to transition their programs of Recertification to programs of Maintenance of Certification (MOC®). All boards are currently working toward this transition. The American Board of Plastic Surgery was one of seven boards invited to present a draft of its Maintenance of Certification® program at the September 2002 meeting of the ABMS Assembly. Also at that meeting, the Assembly voted to approve the guiding principles for the boards to transition from Recertification to Maintenance of Certification®.

The ABPS and the American Board of Pediatrics, have been invited to present details of the Performance in Practice section of their Maintenance of Certification® programs at the upcoming March, 2003 meeting of the ABMS Assembly. The ABPS Performance in Practice and eventual Self-Assessment section of the Maintenance of Certification® program is based on a diplomate's practice pattern. Case lists submitted through an internet based program will be used to provide feedback to individual diplomates regarding patterns of practice and outcomes based on comparisons to national benchmarks. In addition, candidates will have the

opportunity to contribute data electively through an internet program established by the Board in conjunction with ASPS, entitled Tracking Operations Outcomes in Plastic Surgery (TOPS). Generic, aggregate data, devoid of patient and physician identification, will then be used by ASPS to provide more accurate procedural statistics and outcomes evaluation.

The ABMS is faced continually with challenges from self-designated boards and from other certifying organizations. Public education efforts by ABMS are underway to increase the profile of the member boards and the ABMS as the "gold standard" in certification and recertification. Diplomates are requested to refer to The American Board of Plastic Surgery as an ABMS member board when the opportunity arises.

Thank You




EXAMINATION STATISTICS

Oral Examination Failure Rates 1991-2002








