

Q3 Did you study before the exam?

Q4 What resource(s) did you use prior to taking the exam?









Q7 Did this exam enhance your medical knowledge?







Q8 Are you able to apply any of what you learned to your clinical practice?





Technical	There were some issues with the questions advancing too fast when you clicked on the answer button.
Technical	When the question is being answered for a second time, have a confirmation question displayed. A couple times I was going through the exam quickly and clicked on the answer too quickly and could not go back to change it.
	Instead of a test, I would much prefer CME activities that truly provided a comprehensive review of core topics including summaries of the state-of-the-art literature, as well as the blend of scientific principles with practical application.
Suggestion	For example: -The test through the course of multiple discussions provided authoritative answers on specific outcomes and complications following breast augmentation (eg. -The test provided a nice summary of the theory of analyzing the cheek for selecting malar implants
	These types of insights that go above and beyond what is found in textbooks and typical CME reviews (eg. PRS MOC articles) would be nice to get in a more comprehensive format (eg. a series of articles/videos) that would truly add to a practioner's knowledge base (as opposed to getting spot facts based on single examination questions)
Suggestion	Just to add the bibliography to some of the rationale. it will be useful
Suggestion	In reading the email here that the exam will be graded and then a passing level set in June as opposed to being told I passed it and thinking that I would pass it during the taking of it, I'm a bit confused. My strategy would have been different if I thought it was going to be graded on a "curve" on first responses only. I would have looked up more answers before answering them using outside sources (as I perceive to be allowed) instead of using only the knowledge I had at the time. Items	Overall excellent. As with any exam, some items could use some rewording as they could be misinterpreted, and a handful of items did not follow standard guidelines for multiple choice questions, e.g, the answer should be in your mind before you even read the choices, you shouldn't have to read the choices to figure out the answer. Controversial topics also are better avoided. Even so, these items were still educational if they were answered incorrectly, if the rationale were well written, so in the end these were still valuable form a learning standpoint. There were only a handful out of the 200 items I did where the rational actually didn't point the reader to the "correct" answer, or to any answer for that matter. I would think these items would be identifiable on items analysis of the exam. Again, overall I think the objective of continuous learning was pretty well met.
Items	Wish that questions based in a single study for rationale should be eliminated
Items	I thought the exam was a good educational activity. A few of the questions were a bit vague and a few of the explanations unclear but overall good. The only criticism is that I thought there was too much on chemical peels that for most of us have been abandoned areas of practice in favor of more modern skin treatments.
Items	I really liked this new format. the test was very educational while being relatively low stress. Some questions were a little vague and didn't always seem to have a "best one answer" but I'm sure that will get better refined. The rationales overall were well written and very helpful. Getting references for further reading would be nice!
Items	I prefer the new 200 question test to the old proctored test. Unrelated, but important: the majority of questions do not apply to my practice and are not helpful to me. I (and most of the plastic surgeons I know) do not do hand surgery, facial fractures, pressure sores or free flaps.
Items	For a hand certification exam, there appeared to be way too many non-hand questions. I understand questions that address general surgical and even plastic surgical questions - e.g. local flaps, anesthetics, ethics, free tissue transfer and microsurgery. However, I was surprised to see breast questions (e.g. one on gynecomastia). In addition, I thought there were too many questions on wrist surgery. Even though I consider wrist surgery "fair game", most plastic hand surgeons are less versed in wrist surgery. Regardless, thank you for changing the examination format and taking the anxiety and stress out of it a significant improvement for sure and kudos to the board!
Anti-MOC	The MOC is just one more annoyance that does nothing to improve safety or improve surgeon quality. It is a complete waste of time. If surgeons are completing their CME requirements that these activities are more relevant and much more valuable - especially given the great variety of courses available. I have benefited greatly from participating in the Baker-Gordon Symposium and the Cutting Edge. The live surgery and lecture format is the most ideal way to improve and to inform my practice of plastic surgery. Thank you for asking.
