## Maintenance of Certification (MOC-PS®) Physicians with Special Circumstances Policy

**November 2014**

Diplomates who do not practice plastic surgery by providing direct or supervised patient care can maintain their plastic surgery certification status on a continuous basis by engaging in the Maintenance of Certification in Plastic Surgery (MOC-PS®) Program activities. Diplomates must submit a formal request addressed to the Executive Director for consideration of participation in MOC-PS® under the policy for Physicians with Special Circumstances. The diplomate will then receive notification from the Board confirming their status in the MOC-PS® Program.

For those diplomates participating in MOC-PS®, “**surgically active**” is defined as a plastic surgeon currently performing at least one of the ABPS identified tracer surgical procedures in the field of plastic surgery on a regular basis. Surgically active diplomates must meet all requirements of the MOC-PS® Program.

1. For those diplomates who may be surgically active, but do not perform any of the tracer surgical procedures (common plastic surgery operations for the public) on a regular basis, a special approval under the policy for Physicians with Special Circumstances may be provided by the Executive Director.

### **Level I Physicians with Special Circumstances (designation for internal Board use only) –**

Applies to those diplomates who are surgically active but do not regularly perform any one of the tracer procedures available in order to complete the required Practice Assessment in Plastic Surgery (PA-PS) Module in years 3, 6 and 9 of the 10 year cycle. If approved, this diplomate must complete a MOC-approved patient safety activity in lieu of the PA-PS module in years 3, 6 and 9. Diplomates approved at this level are highly specialized, hold hospital privileges and meet **all** other requirements of the MOC-PS® Program.

- ✓ Must have a valid and unrestricted license to practice medicine
- ✓ Must complete a patient safety activity in lieu of PA-PS
- ✓ Must satisfy ALL Professional Standing requirements

2. “**Clinically inactive**” and “**Surgically inactive**” plastic surgeons are defined as those who are currently retired, disabled, on sabbatical, working in administrative positions or research and who are not seeing patients on a regular basis, nor are they regularly performing any of the common plastic surgery operations (tracer procedures). The non-practicing physician, who participates in MOC-PS®, will still be reported to ABMS and to the public as “certified, participating in MOC” and “current” or “not current” on MOC requirements.

## **Level II Physicians with Special Circumstances (designation for internal Board use only) -**

Applies to those diplomates who are surgically inactive. If approved, this diplomate can also complete a MOC-approved patient safety activity in lieu of a PA-PS module in years 3, 6 and 9 of the 10 year cycle and is exempt from certain professionalism requirements. Diplomates must complete the Professional Standing Update; however, hospital privileges, peer reviews, and outpatient accreditation are not required.

- ✓ Must have a valid and unrestricted license to practice medicine
- ✓ Must complete a patient safety activity in lieu of PA-PS
- ✓ Exempt from certain Professional Standing requirements (hospital privileges, outpatient accreditation and peer review)

Change in practice status must be reported to the Board immediately.
